

CAR PARKS

TERMS AND CONDITIONS

- 1. The introduction of a vehicle into our parking areas is subject to acceptance of the present terms and conditions.
- 2. The introduction of a vehicle into the car park only entitles to the use of a single parking slot within the marked areas, according to the applicable tariffs and to the terms and conditions of the present regulation found at the entrance of the car parks and inside of them.
- 3. Customers must park the vehicle within the marked spaces, or else the Airport society is entitled to tow away the vehicle.
 - The costs and relative risks originating from this will be borne entirely by the Customer.
- 4. It is forbidden to keep inside of the parked vehicles any material and/or inflammable or harmful substances, animals and/or any other objects that can represent, for any reason, a hazard or an invitation to breaking in.
- 5. The Airport society is not liable for any damages, committed or attempted thefts of vehicles, accessories, car radios, telephones, luggage or other valuables and property left inside of the vehicles.
- 6. Customers are directly responsible for any damage to persons, animals or property.
- 7. Customers are asked to pay for the parking stay before driving away their vehicle, using the ticket withdrawn at the entrance. From the time of the payment, Customers have a maximum of 15 minutes to exit the car park, after which an additional charge will apply.
- 8. Any request for invoices will have to be made at the time of the payment, filling in an appropriate form available at the Parking Supervision Offices. (*Presidio Parcheggi*)
- 9. In case the entry ticket has been lost or damaged and is therefore unreadable, Customers will be asked to pay for a 30-day stay, as well as being liable in case of unlawful use.



10. The maximum allowed stay is 90 days. Upon expiry of such period, the Customer will have to pay for the stay and retrieve the vehicle. In case this obligation is not adhered to, the Airport society, after having warned the car owner, will proceed with a default action against the Customer and consequent transfer of the vehicle into an authorised car storage.

The costs and relative risks originating from this will be borne entirely by the Customer.

11. It is not permitted to park bicycles, scooters or motorbikes, unless previously authorised. The Airport society has the faculty to remove such vehicles and transfer them into an authorised car storage.

The costs and relative risks originating from this will be borne entirely by the depositor.

12. Guglielmo Marconi car parks are equipped with CCTV cameras with the sole purpose of safeguarding the security and the society's assets, preventing unlawful acts and any kind of harm to the users, passengers and the civil aviation.

The images are viewed, recorded and stored exclusively by the Parking Management of Aeroporto G. Marconi of Bologna S.p.A. and are cancelled not later than 120 days from the recording date. The images are available for viewing only by the Parking Management staff to fulfil the competent tasks.
